Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security Number and Assets
- Income and Credit Scores
- Credit History and Payment History

When you are no longer our customer, we continue to share your information as described in this notice.

How?

All financial companies need to share customer's personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customer's personal information; the reasons Rogue River Mortgage, LLC chooses to share; and whether you can limit this sharing.

What we do

How does Rogue River Mortgage LLC protect my personal information? To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

How does Rogue River Mortgage LLC collect my personal information? We collect your personal information, for example, when you

- apply for a loan or provide your mortgage information
- give us your contact info or give us your income information
- show us your government-issued ID
- tell us about your investment or retirement portfolio

Why can't I limit all sharing? Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes- information about your creditworthiness
- affiliates from using your information to market to you
- sharing for non-affiliates to market to you

State laws and individual companies may give you additional rights to limit sharing.

Definitions

Affiliates Companies related by common ownership or control. They can be financial and non-financial companies.

- ALC Investments, LLC
- DLS Investments, LLC
- Pacific Trust Deed Servicing Company, Inc

Non-Affiliates Companies not related by common ownership or control. They can be financial and non-financial companies.

Joint Marketing A formal agreement between nonaffiliated financial companies that together market financial products or services to you.
